Notice is hereby given of a **regular meeting of the Zoning and Planning Commission** on Thursday, August 11, 2022, beginning at 6:15 p.m. in the **Municipal Building** located at 3800 University Blvd., West University Place, Texas, for the purpose of considering the following agenda items:

Call to Order

- 1. Notices, Rules, Etc.** Matters relating to notices, rules and meeting procedures, identifying parties, swearing of witnesses, etc.
- 2. Public Comments.**
This is an opportunity for citizens to speak relating to agenda items. The speaker can either speak at this time or defer his/her comments until such time the item is discussed. Speakers are advised that comments cannot be received on matters which are the subject of a public hearing. Public comments must be kept relevant to the subject before the Board. The presiding officer shall rule on the relevance of comments. Persons making irrelevant, personal, impertinent, or slanderous remarks may be barred by the presiding officer from further comment before the Board during the meeting. Speakers must limit their presentations to three minutes each.
- 3. 3/7 Exemption.** Matters relating to the single-family homes and the 3/7 Exemption for narrow lots.
- 4. Driveway width requirement.** Matters relating to minimum driveway width and consistency when utilizing 3/7 Exemption.
- 5. Curb Cuts/Corner Lots.** Matters relating to the process for approval of additional curb cuts on one building site and corner lots.
- 6. Old Stock Housing.** Matters relating to the methods for retention and possible replacement of “old stock housing”.
- 7. Sports Courts.** Matters relating to additional specifications/regulations for a variety of sports courts and sports activities, including pickle ball and batting cages.
- 8. SF District Consolidation.** Matters relating to the consolidation of SF-1, SF-2, and SF-3 Zoning Districts into one or more SF districts.
- 9. Selection of Vice-Chairman.** Matters related to the selection of a Vice-Chairman.
- 10. Selection of Secretary.** Matters related to the selection of a Secretary.
- 11. Meeting Minutes.** Matters relating to the approval of minutes from May12, 2022.
